Membership Liability Waiver, Hold Harmless & Assumption of Risk Agreement

I, the undersigned, acknowledge that participation in golf and the use of the facilities at Foster Gulch Golf Course involve inherent risks, including but not limited to bodily injury, illness, death, property damage, accidents, weather conditions, uneven terrain, golf balls, golf clubs, golf carts, maintenance equipment, and the actions of other participants.

In consideration of being granted membership and access to Foster Gulch Golf Course, I voluntarily and knowingly assume all risks, known and unknown, associated with participation in golf and use of the golf course, clubhouse, practice areas, parking areas, and all related facilities and activities.

RELEASE & HOLD HARMLESS

To the fullest extent permitted by Wyoming law, I hereby release, waive, discharge, and agree to indemnify and hold harmless Foster Gulch Golf Course, its board members, officers, employees, volunteers, agents, and representatives from any and all claims, demands, damages, losses, liabilities, actions, or causes of action arising out of or related to injury, illness, death, or property damage that may occur as a result of participation or use of the facilities, whether arising from negligence or otherwise.

RULES, CONDUCT & BEVERAGE POLICY

I agree to comply with all posted signage, local course rules, and safety guidelines; follow the Rules of Golf as established by the USGA; and abide by the Bylaws, policies, and regulations of Foster Gulch Golf Course, including future amendments. Violation of rules or unsafe conduct may result in suspension or termination of membership without refund.

I further acknowledge and agree that no outside beverages are allowed on the golf course or Association facilities. All alcoholic and non-alcoholic beverages must be purchased from the Foster Gulch Golf Course clubhouse in compliance with the Club's liquor license and policies. Violation of this policy may result in disciplinary action, including suspension or termination of membership without refund.

FAMILY & HOUSEHOLD MEMBERSHIP ACKNOWLEDGMENT

I acknowledge that my membership may include access and playing privileges for my spouse/partner, dependent children, and/or other household or family members as defined by Course policy. I affirm that I have informed all persons covered under my membership of the inherent risks associated with participation.

To the fullest extent permitted by Wyoming law, I agree on behalf of myself and all persons covered under my membership to assume all risks and to release, waive, discharge, and hold harmless Foster Gulch Golf Course and its representatives from any claims arising from injury, illness, death, or property damage sustained by any covered individual, whether arising from negligence or otherwise. Each adult participant is strongly encouraged to sign their own waiver.

MINOR PARTICIPANT CLAUSE

If this membership includes participation by a minor under the age of 18, I certify that I am the parent or legal guardian. I consent to the minor's participation and assume all risks on behalf of myself and the minor. I release and hold harmless Foster Gulch Golf Course from any claims arising from the minor's participation, to the fullest extent permitted by Wyoming law.

GOVERNING LAW

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Wyoming. If any provision is found unenforceable, the remaining provisions shall remain in full force and effect.
