

**Foster Gulch Golf Club****Cart Barn Storage & Rental Agreement (Wyoming)**

I/We \_\_\_\_\_ (Print Name(s)) hereby agree to the following terms and conditions regarding the storage and/or use of a privately owned golf cart at Foster Gulch Golf Club.

**ASSIGNMENT OF STORAGE SPACE**

A cart storage space is issued to a specific golfer. If the golfer relinquishes the space, they must notify Foster Gulch Golf Club and the space will be reallocated according to the Club's waiting list. Storage spaces may be transferred only to an immediate family member (spouse, son, or daughter). Storage spaces may not be loaned or used by other golfers.

**FEES & PAYMENT**

Payment in full of all applicable storage fees (cart space, trail fee, and electric fee if applicable) must be made no later than May 1 of the current golf season. Accounts more than 30 days past due may result in termination of this Agreement.

**ASSUMPTION OF RISK & RELEASE OF LIABILITY**

I understand that the operation, storage, and use of a golf cart involves inherent risks, including personal injury, death, theft, or property damage. To the fullest extent permitted by Wyoming law, I release, waive, discharge, and hold harmless Foster Gulch Golf Club, its board members, officers, employees, volunteers, and agents from any and all claims arising from the operation, storage, or presence of a golf cart, whether caused by negligence or otherwise.

**CART CONDITION & USE**

All carts must be maintained in safe working condition. No oil, fuel, or hazardous materials may be stored in the cart barn. No physical alterations may be made to storage stalls without Board approval. The Board reserves the right to disallow any cart deemed unsafe or detrimental.

**ELECTRIC & GAS CARTS**

Members changing from gas to electric carts must notify the Club. Electrical outlets are limited and not guaranteed. Electric carts are subject to the applicable electric storage rate.

**MINOR DRIVER CLAUSE**

If a minor (under 18) operates or rides in a golf cart, the undersigned certifies they are the parent or legal guardian and assume full responsibility for the minor. The undersigned releases and holds harmless Foster Gulch Golf Club from any claims arising from the minor's operation or use of a golf cart, to the fullest extent permitted by Wyoming law.

**REFUNDS**

Pro-rated refunds will be issued if a space is relinquished during the season. No refunds after July 15 unless the space is immediately filled. No refunds after September 1.

**GOVERNING LAW**

This Agreement shall be governed by the laws of the State of Wyoming. If any provision is found unenforceable, the remaining provisions shall remain in effect.
